Each journal selected for Web of Science has an authority file that details the sections and article types that are included and excluded for coverage.

The following journal items typically are excluded from indexing:

- Issue highlights, section descriptions, and editorial statements
- Author indexes, subject indexes, and annual indexes
- Members of an editorial board and/or changes in board membership or journal editorship
- Acknowledgements, announcements and subscriptions
- News blurbs, fillers, trade news, society news
- Call for papers
- Thesis abstracts
- Law decisions

The following journal items might be included in Web of Science:

- Editor’s notes (depending on the content)
- Book reviews (processed for journals included in ESCI, AHCI and SSCI, but not usually for journals in SCIE)
- Art exhibits; scripts; poetry; reviews of film, music, recordings, theatre, TV, radio, video, dance, and fiction (processed only in journals included in ESCI and AHCI)
